The purpose of the Solent Swim 2010 is to continue to raise money for Champion Behaviours in order to deliver more workshops in local schools. Event posters and sponsorship forms will be available to support you in collecting sponsorship money for your SAFE, SUCCESSFUL and FUN swim.

Each swimmer's entry will be confirmed on receipt of a non-refundable £100 cheque together with this signed form. Additional sponsorship monies raised will be gratefully received within 1 month of the swim. We are requesting swimmers to raise at least an additional £100 for the swim this year. This will be verified prior to the swim. This reflects increased costs and also the demand for places which has increased.

Insurance

Please note that the organisers are unable to provide insurance for swimmers when they are in the water. Participants should make their own insurance arrangements if required.

Whilst safety canoes and boats will marshal the event and predominantly be swimmer support craft, swimmers must take individual responsibility and swim at your own risk.

Points to note

- On the day, the **final** decision to whether the swim will proceed will be made by the head of the canoe fleet and the Racenewforest organisers.
- If the swim is postponed we will endeavour to have a back up date. If the race is unable to take place in 2010 – sponsorship funds collected to that will be retained by Champion Behaviours.
- Swimmers must show evidence that they are fit and able to swim the proposed 2.25 – 3 mile distance in open water.
- Proof of having completed the 2007 or 2008 swim is sufficient. Alternatively, evidence of having completed an open swim of notable distance and **attendance at group training swims**.
- Swimmer event packs will be sent out nearer the time.
- Event posters and sponsorship forms are available.
- Swimmers email addresses will be shared amongst the organisers and fellow swimmers to co ordinate the event.
- Medical information will be kept strictly private unless required by medics on the day.
